REMEDIES IN EVENT OF DEFAULT – IN THE EVENT OF NON-PAYMENT OR DEFAULT UNDER THE OBLIGATIONS HEREIN, THIS AGREEMENT SHALL TERMINATE AND BECOME NULL AND VOID WITHOUT ANY RIGHT BY LICENSEE TO SAVE FORFEITURE BY PAYMENT OF ANY SUMS DUE OR OBLIGATIONS HEREUNDER.
